LEGAL ASSISTANCE IN THE UNITED KINGDOM

ADMIRALTY, S.W.1,

23rd September, 1943.

The following Order having been approved by My Lords Commissioners of the Admiralty is hereby promulgated for information and guidance and necessary action.

To all Commanders-in-Chief, Flag Officers, Senior Naval Officers, Captains and Commanding Officers of H.M. Ships and Vessels, Superintendents or Officers in Charge of H.M. Naval Establishments, and Admiralty Overseers concerned.

4523.—Legal Assistance in the United Kingdom

Except in cases of special emergency and coroner's inquests (K.R. and A.I., Article 1137), Admiralty authority should be obtained before the assistance of the local agents to the Treasury Solicitor is sought (K.R. and A.I., Article 1141).

2. Where legal assistance is obtained locally, the officer instructing the agent is, when first communicating with him, to state that the bill should be drawn on "agency terms". The agent should also be requested to send his report and the bill to the officer instructing him. The bill is to be formally certified to the effect that the agent was so instructed and duly attended, or performed the services stated, and then be forwarded to the Treasury Solicitor, Storey's Gate, London, S.W.1, for payment. The latter does not require a copy of the report, which should be forwarded to the Admiralty in all cases.

3. *Traffic Accidents.*—In all cases of inquests or police proceedings arising from traffic accidents, the procedure laid down in paragraph 23 of A.F.O. 670/43, is to be followed.

4. *Lists of Agents.*—A list of the local agents of the Treasury Solicitor for matters connected with ships is given under the section entitled "Judicial Department" in the Navy List. For all other legal purposes any of the agents named in the appended list may be instructed. In criminal prosecutions (other than prosecutions for failure to perform fire-watching duties) the agent should be instructed as on behalf of the Director of Public Prosecutions, to whom the bill should be forwarded for payment (Address: Devonshire House, Piccadilly, London, W.1).
