He is responsible to Admiral (Air) for the remaining functions hitherto carried out by F.O.C.T. and C.F.T., viz., the control and administration of individual aircrew training, of the Naval Operational Training Units or their equivalents and of deck-landing training and the administration of Deck-landing Training Carriers. (Admiral (Air) will directly administer the Trials Carrier; arrangements for the administration of other carriers formerly administered by F.O.C.T. will be promulgated separately.)
- 4. In accordance with paragraphs 2 and 3 above, Admiral (Air) will be directly responsible for the administration of the following establishments:—

6538.—Air Engineer Officer's Writer

(N. 4198/44.—15 Nov. 1945.)

Approval has been given for the payment of 6d. per diem to ratings of the Air Mechanic Branch qualified for and employed on the duties of Air Engineer Officer's Writer.

- 2. Air Engineer Officer's Writers will be employed in the Air Engineer Officer's office, not only for typewriting but also for general duties requiring knowledge of Air Publications, K.R.&.A.I., B.R's and Forms, methods of statistical recording and the preparation of defect lists.
- 3. The course for Air Engineer Officer's Writer will be held at the School of Aircraft Maintenance. To qualify for admission ratings must be Acting Leading Air Mechanics or above, have passed E.T.1., be recommended by the Air Engineer Officer and approved by the Commanding Officer. They should be able to write well, be good at arithmetic and have an inclination for office work. A knowledge of typewriting or shorthand is not essential but will be an advantage when selections are made.
- 4. Applications to be put on the roster for the course should be made to the Commodore, R.N. Barracks, Lee-on-Solent. Preference will be given to ratings on C.S. or S.S. engagements.
- It is not possible at present to entertain applications for the course from ratings serving outside the United Kingdom.
- 6. Successful completion of the course is to be noted on the rating's history sheet. Ratings who have passed the course and are employed as Air Engineer Officer's Writers will require the usual qualifications for advancement.

- 7. Suitable Wren Air Mechanics are eligible for this employment, their rate of pay following the general principle applied to their emoluments. Unless, however, definite instructions are given no Wren Air Mechanic rating is to be given the special course.
- 8. The allowance may be paid to Air Mechanic ratings who are carrying out the duties to the satisfaction of the Air Engineer Officer, and are borne in lieu of Writer ratings or Wren Writers (General) at present specifically allowed by complement for this purpose, until they are replaced by ratings who have undergone the course. The allowance may be paid to such ratings as from the 9th November, 1944, or the date of commencing the duties, whichever is the later. Particulars of additional billets will be promulgated as soon as these have been decided.

6539.—Aircraft Maintenance Branches—Transfer of Airmen from Royal Air Force— Educational Tests

6541.—Foreign and Colonial Currencies

(W.G.F.-15 Nov. 1945.)

A number of H.M. ships have recently arrived in the United Kingdom with considerable balances of foreign currencies, for which opportunities of disposal are now infrequent. In most cases the need for secrecy of movements no longer precludes opportunity being given for the exchange of local money in the hands of the ship's company before departure from a foreign port, and every endeavour is in future to be made to land all foreign currency in its country of origin before leaving the station.

- 2. Paragraph 23 of A.F.O. 3990/45 is to be cancelled and the following substituted:—
- "23. (a) Surplus Balances arising in H.M. Ships and Establishments abroad.—Supply Officers and Cashiers should make every effort to dispose of surplus balances of foreign, etc., currencies by repatriating them in H.M. ships to the countries of their origin as opportunity offers. Such officers should endeavour to avoid encumbering themselves with currencies of which they have no opportunities of disposing, but if they do find themselves in possession of currencies which it is quite impossible for them to exchange or to return to their countries of origin,

they should report the matter to the Director of Navy Accounts (Branch 5A, Harrow) for instructions. H.M. ships proceeding from a foreign station to the United Kingdom or to another area should make every endeavour before departure to dispose locally of surplus foreign, etc., currencies; in most cases the need for secrecy of movements no longer precludes opportunity being given for the exchange of local money in the hands of the ship's company before departure from a foreign port and H.M. ships will, in general, be expected to have landed all foreign currency in its country of origin before leaving the station. In cases where this is impracticable surplus foreign money should be landed at the first port of call from which repatriation can be arranged.

- (b) Foreign, etc., Currencies in H.M. Ships and Establishments at Home.—Supply Officers and Cashiers at home who receive foreign, etc., currencies as a result of this Admiralty Fleet Order are to dispose of them as stocks accumulate, at intervals of not less than a month, as follows:—
 - To Paymaster of Contingencies, Admiralty, Room 57, Queen Anne's Mansions, London, S.W.I.

British Military Authority notes.

Note.—When transferring Italian Metropolitan lire, the place of origin and the rate of exchange should be indicated on the relative transfer documents.

- (ii) To Cashier, H.M. Dockyard, Chatham—

 Dutch gulden (florins).

 German marks.
- (iii) To Cashier, H.M. Dockyard, Rosyth— Danish and Norwegian kroner.
- (iv) To Cashier, H.M. Dockyard, Portsmouth— All other foreign and colonial currencies.

Note.—In cases where H.M. ships arrive in the United Kingdom with appreciable quantities of U.S. and Canadian currencies on board it is preferable, especially if London can be more easily reached than Portsmouth from the ship's location, to dispose of these currencies direct to the Bank of England. When this course is followed the Bank should be given notice in advance and the consignment should be delivered to the Bank of England, Dealing and Accounts Office, Threadneedle Street, London, E.C.2. In such cases the Bank will give credit through the Admiralty account, and the sum involved should be treated by the ship as a transfer of cash to the Director of Navy Accounts, the relative supply and receipt notes being forwarded, together with the Bank's receipt, to the Director of Navy Accounts (Branch 5A, Harrow).

6542.—Dental Centres at Home and Abroad—Disposal of Records on Closing Down

(M.D.G. 69517/45,-15 Nov. 1945.)

Records of dental treatment on Forms M.228A and M.228B are to be disposed of as follows on closure of Naval dental centres at home and abroad.

- 2. From Dental Centres at home, including those at R.N. air stations, records are to be sent, legibly marked as to their origin, to the Command Dental Surgeon of the command in which the establishment is situated.
- 3. From Dental Centres in commands abroad the records should be forwarded by the Command Dental Surgeon, where one is borne, as indicated below :-
 - (a) East Indies: to the Command Dental Surgeon, R.N. Barracks, Ports-
 - (b) Mediterranean: to the Command Dental Surgeon, R.N. Barracks, Chatham.
 - (c) From centres in all other Commands (e.g. South Atlantic) or detached establishments abroad: to the Command Dental Surgeon, R.N. Barracks, Devonport.
- 4. Particular care is to be taken that Forms M.228A invariably accompany Form M.228B, to which they relate, as if these forms are separated neither is of any value for record purposes.

6543.—Adult Education—Educational and Vocational Training—Equipment and Utensils for Housecraft, Cookery and Needlework

(N.19030/45.—15 Nov. 1945.)

Collections of utensils and equipment have now been specified for the following pre-vocational courses :-

- (i) Housecraft.
- (ii) Cookery.
- (iii) Needlework.
- (iv) Subsidiary cookery.

Voltage of electrical supply should be stated when making demands.

The equipment and utensils included in each unit are listed in the Appendix to this A.F.O.

- 2. Tables are not included in the units and should be demanded in the usual way. Cupboards are included in (iv) but in all other cases should be demanded through the usual channels.
- 3. A demand for a unit should only be submitted if it is reasonably certain that it will be fully used for a minimum of eight hours each week.
- 4. The following schedule shows for each unit the minimum floor space required for reasonable working conditions.
 - ... 500 sq. feet. (i) Housecraft 500 sq. feet. (ii) Cookery (iii) Needlework 400 sq. feet. (iv) Subsidiary cookery Existing galley.

A room may be said to be suitable for housecraft or cookery only if the existing facilities include hot and cold water with a sink or sinks.

The floor space required is to be obtained as far as possible from existing resources. Should new construction or requisitioning of additional premises be required prior Admiralty approval is to be sought.

- 5. All demands should be made through the Supply Officer of the ship or establishment. Items marked "V" should be demanded from the nearest victualling yard or depot and those marked "NS" from the appropriate (superintending) Naval Store Officer. Items marked "LP" may be obtained by local purchase on Form S.22 as laid down in A.F.O. 1652/45, paragraph 38 (c), (d) and (e).
- 6. Consumable materials should be ordered as laid down in A.F.O. 1652/45, paragraph 38, sections (c), (d), (e) and (h) and/or A.F.O. 2240/45.

- 7. Equipment and utensils will be supplied to the Supply Officer of the ship or establishment and are to be taken on charge.
- 8. Articles made by trainees may be sold to them or other Service personnel at a price equal to the cost of materials used in accordance with A.F.O. 1652/45, paragraph 38 (o). Prepared food should be dealt with in accordance with A.F.O. 2240/45, paragraph 3. Sums so obtained are to be credited to Navy votes.
- 9. Expenditure on equipment replacement and consumable materials.—(a) Commanding officers may sanction a net expenditure on equipment replacements and consumable materials for prevocational courses up to a maximum of 1s. per hour per unit that each unit is in use for organized instruction. It is intended that this sum should represent the average expenditure over all units in use. It may thus be exceeded in some cases provided there is a corresponding reduction in others.
- (b) If, in exceptional circumstances, expenditure in excess of this limit is necessary the Commander-in-Chief's approval must be obtained.
- (c) By net expenditure is meant the balance between the cost of stores, other than complete units, demanded or purchased and the sums realized by the sale of articles in accordance with paragraph 8.
- (d) Expenditure on equipment and materials under this A.F.O. is to be reported in accordance with A.F.O. 1652/45, paragraph 5.
- 10. The arrangements described in this A.F.O. do not alter in any way the provision made in A.F.O. 1652/45, paragraph 38, for the supply of equipment and materials for handicrafts, etc.

*6544.—Teachers—Emergency Recruitment and Training of, in Northern Ireland—Applications for Training

(N. 26252/45.—15 Nov. 1945.)

The Ministry of Education for Northern Ireland is making arrangements for a special intensive training scheme, similar to those outlined in A.F.O.4107/45 for England and Wales, and Scotland, designed to meet the shortage of teachers in the public elementary schools. This scheme, which will be open to ex-members of H.M. Forces, will provide a course of training which will vary in length according to the age, previous experience, and educational attainment of the individual student. In no case is the course likely to be shorter than one year or longer than two years. On its conclusion, successful candidates will be qualified to teach in public elementary schools in Northern Ireland subject to a probation period of actual teaching.

- 2. The normal age limits will be 21 to 35 years.
- 3. Candidates will be expected to have a sound general education. Possession of the Ministry's secondary school Senior or Junior Certificate or of the Junior Technical or Junior Commercial Certificate will normally be looked for as an educational qualification, but may not, in every case be insisted upon. Success in the Forces Preliminary Examination will also rank for qualification.
 - 4. Tuition will be free.
- Maintenance allowances, both for the candidate and for wife and children, if any, will be available where appropriate.
- 6. Applications.—Application forms, and a pamphlet with information regarding the methods of selection of candidates, nature of the course, salaries of qualified teachers in Northern Ireland, etc., may be obtained free of charge from the Secretary, Ministry of Education, Stranmillis House, Belfast.
- 7. Candidates in H.M. Forces must await their release in the ordinary course in Class A before taking up a course of training. Meantime, however, the Ministry of Education, Northern Ireland, is prepared to receive applications and to deal with them so that men and women may know as soon as possible whether they are likely to be admitted to training when in the ordinary course they are released. Candidates accepted in this way will be required to undergo a medical examination before entry to a training college, and acceptance will therefore be subject to the candidates fulfilling medical requirements. The demand for teachers will continue for a considerable period, so that men and women in the latest release groups will have as good a chance of training as the first to be released. On the other hand,

acceptance for training will make no difference to the date of a candidate's release, which will take place in Class A according to his or her group, and subject to the requirements of the Service.

8. It may be possible if there is sufficient demand to organize modified courses, for applicants who desire to qualify themselves for service as teachers of commercial or technological subjects in the technical schools.

- (a) on the 15th August, 1945, they had completed at least twelve months' service in an adult capacity (but including non-adult service in a seagoing ship or abroad), and
- (b) on the 1st December, 1945, they had at least twelve months' further service to complete before the expiration of their engagement.
- 2. Men with less than twelve months' service to complete will be eligible for the special leave if they re-engage.
- 3. Subject to qualification under paragraph 1 (a) of this Order, the following will also be eligible for this special leave:—

Reserve Officers (permanent and temporary), and temporary R.M. Officers, who are transferred to permanent or extended service commissions.

Short Service Officers transferred to permanent commissions.

Short Service R.N. (A) Officers transferred to permanent commissions or retained on the Active List to complete fifteen years' service.

"Hostilities Only" ratings and R.M. ranks who enter into Continuous or Special Service engagements.

- 4. The special leave is additional to any other Service leave, e.g., foreign service, or re-engaging leave, to which the officer or man may be entitled. No officer or man who is granted release leave (B.R. 1281, Part I, paragraph 284) will, however, be eligible subsequently to receive this "End of the War" leave.
- 5. Operational requirements and the many commitments of the Fleet will make it impossible for the leave to be granted immediately and simultaneously to all those entitled, and a considerable time will therefore elapse before all those eligible will have received this leave. Further, it may be impracticable in some cases for the whole amount to be taken in one period, and arrangements may therefore be made to take it over a period or by instalments. In either case, to ensure that any balance due is granted at the next convenient opportunity, the amount of leave taken is to be noted in pay books and on conduct sheets and, in the case of officers, is to be reported to the Secretary of the Admiralty.

6553.—Royal Air Force Personnel Serving in H.M. Ships—Payment of (D.N.A. 29503/45.—15 Nov. 1945.)

Where there is no Royal Air Force Accountant Officer on board, and payments to airmen are consequently made by the Naval Supply Officer, the following procedure is to be followed in place of that laid down in King's Regulations and Admiralty Instructions, Appendix XXXIIA, Clauses 9 and 10.

2. The detachment pay rolls (R.A.F. Form 1510) are to be made out in triplicate; one copy duly receipted by the airman, with the date of payment clearly shown thereon, is to be forwarded to the Royal Air Force Accountant Officer, who, on receipt of the form, will forward his receipt for the money direct to the Director of Navy Accounts (Branch 5A). At the same time the Supply Officer is to produce a Supply Note (Form S.5 or S.5A) indicating thereon the ship's name, date of payment, and the amount paid (particulars which should coincide with those shown on the detachment pay roll), and send it to the Director of Accounts (Accounts 1B), Air Ministry. Supply and receipt notes are not required to be sent with R.A.F. Form 1510.

- 3. Duplicate and triplicate copies of the detachment pay roll are to be retained by the Supply Officer as vouchers to his original duplicate cash accounts.
- 4. In the case of R.N. Air Stations in the United Kingdom, there is no objection to direct adjustment by cheque being arranged with the appropriate R.A.F. Accountant Officer. In such an event no entries in the cash account are required.

To overcome the present difficulty of applying the provisions of Article 26, paragraphs 7 and 9, B.R.1066 (Advancement Regulations), i.e. of determining whether a man transferring from one branch to another may or may not count all his previous service for advancement to the "able seaman" grade in his new branch, it has been decided that the authority for transfer and the amount of time to count towards subsequent advancement is to be noted on Service Certificates.

2. A tick is to be placed in the "Cause of Discharge" column against the new rate and, at the foot of page 2 a similar tick, against which should be shown time to count and authority for transfer, e.g. "Can count......previous service towards advancement to.....(B.R. 1066, Article 26 (seven), or 26 (nine)) ". †6556.—Permanent Officers—Voluntary Retirement

(C.W. 68972/45.—15 Nov. 1945.)

Since the end of hostilities Their Lordships have received a number of applications from permanent officers to be allowed to retire or to resign.

- 2. Voluntary retirements and resignations have necessarily been in abeyance for the past six years, but Their Lordships now consider it desirable that officers should be given some indication of the policy which will be followed during the transitional period from war to peace conditions.
- 3. While Their Lordships are not prepared to sanction any measures likely to prejudice the release of Temporary Officers to civil life, they no longer wish to maintain a complete embargo on the voluntary retirement or resignation of permanent officers. It must, however, be recognised that the numbers who can be released during the coming months will be small. Each application will accordingly be judged on its merits according to the particular circumstances of each officer and to the requirements of the Service, having regard also to the "age and service" group which has become due for release in the particular Branch at the time.

The number of fuze used should also be found on the outside of all boxes.
- 3. R.N. Armament Depots (Abroad).—Details of quantities of any ammunition fuzed No. 250 in store together with any landed by ships are to be reported by signal to D.A.S., Bath, for disposal instructions.
- 4. R.N. Armament Depots (Home).—Details of quantities of any ammunition fuzed No. 250 in store, together with any landed by ships, are to be reported to D.A.S., Bath, for disposal instructions, and not returned to Central Armaments Depots at Longtown, or Corsham, as hitherto.

- 2. The Superintendent of Diving will be responsible to D.T.M. for research and development in diving, which term will include the co-ordination of technical research work in conjunction with other technical departments, the development, testing and proving of new equipment, modification of existing equipment, the investigation of new inventions and ideas and the examination and testing of equipment received from foreign sources.
- 3. The Admiralty Experimental Diving Unit, previously operating at the works of Messrs. Siebe Gorman & Co., Ltd., has also been transferred temporarily to H.M.S. "Vernon".
- 4. All matters relating to research and development in diving as outlined in paragraph 2 above and the work of the Experimental Unit should be referred to the Superintendent of Diving. Such matters are not to be referred direct to the manufacturers of diving gear.

6570.—Main Batteries—Casual Replacement of Cells—REPORTS Submarines

(D. 21569/45.—15 Nov. 1945.)

Cells in fabricated containers are higher than cells in neoprene ebonite containers. The difference in height varies, due to manufacturing tolerances, but is nominally \(\frac{1}{4} \)-in.

- 2. When, therefore it is necessary to exchange faulty cells in submarine main batteries, it is essential that the containers in any one section should remain of the same type, that is neoprene ebonite or fabricated rubber lined. Only in exceptional circumstances, when insufficient spare containers of the correct type are available and the delay in obtaining spare containers cannot be accepted or when other methods, such as cutting out cells cannot be adopted, should fabricated containers be used with ebonite containers or vice versa. Such circumstances should rarely arise.
- 3. Should such exceptional circumstances arise, steps must be taken to compensate for the difference in height of the cells either by packing up the replace cell or by setting the intercell connectors as appropriate. Particular care must also be taken to ensure that the replace container is adequately wedged.
- 4. In any such case, the replacement is to be considered temporary and a replace container of the appropriate type is to be installed as soon as possible.
- In all cases of casual replacement of cells, a report quoting the serial number of the battery concerned should be forwarded to the Admiralty.

6571.—Centre-Pivot System of Leading Cables into Gun Mountings and Directors—Cable Failures—REPORTS

Ships concerned

(T.1127/45.—15 Nov. 1945.)

Recent reports from sea have indicated a tendency for failures in flexible cables installed in centre-pivot lead-in systems to gun mountings and directors. These reports have not always been sufficiently detailed to enable an accurate estimate to be made of the cause of failure.

- 2. In order to provide a reliable indication of the service being obtained from centre-pivot lead-in cables, every instance of failure should be reported to Admiralty, with full details, viz., nature of failure, pattern number of cable, description of mounting or director, length of time cable has been in service and date of manufacture of cable (if obtainable). Any additional details considered relevant, such as peculiarities in the form of the lead-in system concerned, obstructions in way of twisting cables, etc., should also be provided.
- 3. Ships in which failures have occurred in centre-pivot systems within the past 12 months, or in which failures occur in the future, should report at the earliest possible moment, reference to this Order being made in the report.

6572. Multiphones Replacement by Sound-Powered Telephones

(T/C.D. 431/45.-15 Nov. 1945.)

In view of the adverse reports received on the performance of multiphones, it has been decided that they may be replaced by sound powered telephones when they become defective.

- 2. The existing wiring should be utilised where possible and the work of replacement undertaken by ships' staffs.
- 3. The existing multiphone circuits run in fire control multicore cables may not prove satisfactory for use with sound powered telephones due to interference from magslip and fire control instruments, and because the cables are not twisted pair cables. If interference be experienced and twisted pair spare cores are not available in the telephone circuits, action should be taken in accordance with paragraph 6 below.
- 4. The following types of sound powered telephones are to be used for the undermentioned services when replacements are effected:—
 - (a) Bomb lift communications-Mark XV, Pattern 13231 (hand set).
 - (b) Ammunition hoist motors-Mark X**, Pattern 12500 (head set).
 - (c) Fire control communications-Mark XV, Pattern 13231 (hand set).
 - (d) Miscellaneous communications—Mark XV, Pattern 13231 (hand set).

When fitting these telephones, care should be taken that the "safe distance" requirements of magnetic compasses are not infringed and that Mark XV and Mark X** telephones are not fitted closer than 5 and 6 feet respectively from any magnetic compass.

- Multiphones rendered redundant by paragraph 20 of C.A.F.O. 998/45 are not affected by this order.
- Where the work involved is beyond the capacity of ships' staffs or rewiring is necessary, an item should be inserted in the defect list.
 - 7. The sea store establishments concerned will be amended.

6573.—Emergency Electrical Supply Arrangements

British Built Major War Vessels (Except Submarines)

(T. 1720/45.—15 Nov. 1945.)

In ships where the shore supply cable terminates in the M.S.S., short lengths of cable fitted with suitable terminals should be provided to enable the output from one of the pairs of 400-amp, fuses referred to in (i) to be connected to the shore supply terminal.

Paragraph 23. 1. Terminals and connections.

All reference in columns headed "Details" and "Remarks" to "§-in. B.S.F. hexagonal nuts" and "§-in. B.S.F. hexagonal nuts" to read "§-in. B.S.P. hexagonal nuts" and "§-in. B.S.P. hexagonal nuts" respectively.

6574. Ships' Main Dynamos Brushgear

(T. 02138/44.—15 Nov. 1945.)

War experience has shown that after being subjected to severe shock due to underwater explosion the brush arms of certain main dynamos may be displaced sufficiently for the brush boxes to touch the revolving commutator. This in turn can result in twisting of the brush arms about their points of support and damage to the commutator surface.

- 2. Ships' staffs should tighten up all bolts securing brush arms to brush rockers on all main dynamos and periodically check that these do not slack back due to vibration. If necessary any bolt head locking devices should be renewed.

- (ii) In destroyers it is intended, wherever possible, to resite the emergency transmitter-receiver aft in the same office as the second Type TBS to form an emergency W/T office. Type TCS(E) or TCS(E 12 volt) (including receiver) with its battery outfit should be removed from its position aft and resited in the emergency W/T office concurrently with the fitting of Type TBS if time permits, or as soon after as conveniently possible. - Power Supplies. Type TBS requires a maximum D.C. supply of 2,000 watts at 220 volts, and an A.C. supply of 260 watts at 230 volts 50 cycles per second. The power supply wiring is shown on A.S.E. Drawing No. 40473 in Specification B159/R1.
- A.C. supply outfit DQB is to be fitted in the second W/T office of leaders and in the emergency W/T office aft in destroyers to supply Type TBS. Where it is not practicable to provide space for a proper emergency W/T office A.C. supply outfit DQB should be fitted as close as possible to Type TBS.

The D.C. supplies for Type TBS and A.C. supply outfit DQB are to be taken from separately switched and fused output ways on a distribution board fitted in the same compartment as the Type TBS.

 - (b) Equipment already allocated for Dutch port parties for the Netherlands East Indies and to be provided from local Far Eastern sources.

Supplies are not to be issued nor services rendered as a charge to Navy Votes if they involve local payments to third parties outside the Colonial Empire (e.g., in the Dominions and foreign countries.)

- (2) Training of Dutch Naval personnel in the United Kingdom for service in the Far East.
- 2. The reporting and accounting procedure for these services or supplies remains as hitherto.

- 5. Warrant and supplying yards or depots should arrange supply in the usual way to ships of new construction concerned, except H.M.S. "Vanguard", for which arrangements have already been made.

- (ii) Before raising a demand for an electric clock, the Electricity Supply Authority should be approached, through the appropriate Admiralty Electrical Officer, regarding the suitability of supply. Further, it should be determined that the building in which the clock is proposed to be installed will not be disconnected from the supply (vide H.D.R. 270, paragraph 2, and 272, paragraph 9). The clock should only be installed where minor alterations or additions to existing circuits are involved, and it is not intended that circuits which would normally be made dead under the regulations quoted should be maintained, solely to operate an electric clock. In such a case, a clock, Pattern 305, should be demanded.
- (iii) Demands for clocks, Pattern 309, should be forwarded to D. of S. and endorsed to the effect that the conditions of (i) and (ii) above are satisfied, viz.:
 - (a) Electricity supply is suitable and frequency controlled.
 - (b) Supply will not be interrupted under normal conditions.
 - (c) Installation can be effected without extensive additional wiring.

6622.—Annual Leave in 1945—Temporary Civilian Non-Industrial Staff

(C.E. 55848/45.-15 Nov. 1945.)

Where no annual leave allowance for the grade has been laid down, 24 days' annual leave may be allowed during the current leave year to all temporary officers with scales or ranges of pay which proceed beyond £400 per annum (basic), in the case of men, and £320 per annum (basic) in the case of women. This arrangement will not, however, operate in any case where it would give a temporary officer more annual leave than a permanent officer (established or unestablished) serving in the same or a comparable grade.

2. The annual leave of temporary officers who are serving in a grade for which no annual leave allowance has been promulgated and with a scale or range of pay which has a maximum of not less than £375 per annum (basic) in the case of m:n, and £300 per annum (basic) in the case of women, and whose present entitlement is less than 24 days, may be increased to 24 days after three years' continuous

service in a Government department in any grade, with effect from the 1st May, 1945, or from any later date during the leave year on which three years' continuous service is completed. This increase will not, however, operate in any case where it would give a temporary officer more annual leave than a permanent officer (established or unestablished) serving in the same or a comparable grade.

3. The foregoing arrangements are subject to the usual conditions that leave is subject to the needs of the work and will apply only during the current leave year or until such times as the authorized annual leave allowances of the grades concerned are decided and promulgated.
