

# HOSPITAL TREATMENT OF MEMBERS OF PERMANENT N.O. 1 NAVAL FORCES. 1915.

- 1. With reference to Navy Order No. 83/1913, and statement showing particulars of hospital charges for Naval patients, dated 1st August, 1913, Commanding Officers of ships are empowered to send cases of a serious nature to civil hospitals ashore; it is at the discretion of the Senior Officer present to approve of superior accommodation in the case of Officers.
- 2. Should the necessity arise for landing sick Officers or Men at a place where there is no hospital or sick quarters, the Commanding Officer is to be guided by King's Regulations, Article 1246.
- 3. In cases where an Officer or Man elects to be treated in a private hospital, or by a private practitioner, a public hospital, with approved accommodation, being available, the expense incurred consequent on this decision will not be allowed by the Department. The patient in such a case will be responsible for, and will be required to pay, all the expenses involved.
- 4. Except in cases of emergency, operations shall not be performed by civil practitioners upon Officers and Men at Service expense, except in hospitals with which the Service has arrangements.
- 5. When an operation is necessary in cases of emergency, the Senior Medical Officer present, where practicable, is to be consulted, and if he considers it desirable to obtain outside assistance, he shall arrange for it at as moderate a charge as practicable, and should only exceed the fees on the undermentioned scale in exceptional circumstances
- 6. The Medical Officer who arranges the operation is to send a report in full on the subject to the Naval Board, through his Commanding Officer.
- 7. The statement forwarded to Commanding Officers giving particulars and terms of treatment at hospitals for Naval patients has been amended, and copies of the revised statement have been forwarded to Commanding Officers. The following institution has been approved since issue of the statement, and should be added thereto.

Western Australia.—Grosvenor Hospital, Beaconsfield (Fremantle): Officers, £3 3s. per week; Men, £2 2s. per week. (N. 14/4669.)

N.O. 2 ADVANCEMENT OF ROYAL NAVY RATINGS LENT TO ROYAL AUSTRALIAN NAVY.

1. With reference to the question of the advancement of Active Service Ratings lent from the Royal Navy to the Royal Australian Navy to meet Royal Australian Naval demands, it is notified for information that in cases where such ratings belong to a class in which the authority to grant the higher rating is the Commodore of a Home Depôt, (i.e., ratings promoted from Home Port Division Rosters) any advancements made in these classes on the authority of the Naval Board can only be regarded as local. In the event of their turn not having arrived for advancement on the Home Depôt Rosters prior to completing their period of engagement in the Royal Australian Navy, the ratings so concerned must revert to their Royal Navy Rating on return to that Service.

2. Where a rating is advanced to a higher rating to fill an actual vacancy in the complement, and the authority to grant such rating is the Captain, no reversion takes place on return to Royal Navy. (N. 14/5823.)

#### RETIRED PAY OR PENSIONS OF OFFICERS RETIRING FROM THE ROYAL NAVY.

With reference to the question of retired pay or pensions of Naval Officers who may retire from the Royal Navy while serving in the Royal Australian Navy, advice has been received from the Admiralty that an Officer severing his connexion with the Royal Navy at his own request, can, under no circumstances, be granted a pension from Imperial Funds unless he is eligible for optional retirement under Naval Regulations. (N. 14/5474.)

## EXAMINATIONS IN FOREIGN LANGUAGES AND NAVAL N.O. 4 HISTORY. 1915.

1. With reference to Admiralty Circular Letter No. 7 of 14th February, 1913, in regard to the above subject, the Admiralty advise that Lieutenants, Royal Navy, lent for service in the Royal Australian Navy, are eligible to enter for the examinations in Foreign Languages and Naval History.

2. Officers of the Royal Australian Navy may also enter for these examinations under the same conditions as Officers of the Royal Navy.

3. It is pointed out that under the terms of Admiralty Weekly Order No. 492 of 5th September, 1913, all Officers of the relative rank of Lieutenant under five years seniority, are eligible for the competition in foreign languages.

4. In regard to Officers of the Royal Australian Navy, they will be grouped parallel to Officers of the Royal Navy as regards prizes, medals, or certificates; duplicate prizes, &c., being awarded to any Officers qualifying for them, at the expense of the Commonwealth Government. (N. 14/6088.)

#### COURSES OF INSTRUCTION FOR ARMOURER RATINGS. N.O.

With reference to Navy Order No. 94/1914, the Courses of Instruction for Armourers' Mates and Armourers, at Ordnance Depôt, Spectacle Island, Sydney, are to be altered to 10 days and 15 days respectively. (N. 14/5773.)

#### N.O. 6 DISPOSAL OF DUPLICATE RECORD BOOKS.

1. With reference to the disposal of duplicate record 1915. books of trainees transferred from Military to Naval Service, or vice versa, it is notified that the duplicate record book of any trainee who has previously served in the Military, Senior Cadets, or Citizen Forces, and is subsequently transferred to the Royal Australian Naval Reserve (O), is to be kept in the custody of the trainee's Naval Commanding Officer, together with his Naval Duplicate Record Book, as it is essential that when a trainee reaches his 26th year his Commanding Officer, whether Naval or Military, should have a full record of his service, in order that it may be accurately ascertained whether the trainee is liable to any further service under Section 133 of the Act. If the original Military Record Book be received, it should be handed to the trainee

2. Similarly, if a trainee who has served in the Royal Australian Naval Reserve (O) is transferred to the Military, his Duplicate Naval Record Book should be forwarded to the Area Officer concerned for his retention.

3. The receipt of such Military Record or Duplicate Record Book (Forms C.M. 7 and 8) is invariably to be acknowledged to the Area Officer from whom received by the trainee's Commanding Officer (vide Navy Order No. 12 of 1914).

- 1. Upon the realization of the clothes and effects of men discharged to shore "D.D." or "Run," Form A.S. 46 is to be rendered without delay to the Director of Navy Accounts.
- 2. The rendering of Form A.S. 46 does not dispense with the transmission of Form A.S. 1031z., which must be rendered in all cases (vide Navy Orders 43 of 1914, and 69 of 1914).
- 3. In the case of men discharged to shore or "D.D.," the net sum realized from the sale may be credited to the ratings account in "Other Credits" column, and the words "Sale of Effects" entered in the "Description" column of the ledger.
- 4. Under no circumstances, however, should a deserter's account be so credited.
- 5. When charging the accounts of purchasers, it is particularly necessary that the letters "D.M.E." be utilized to designate charges for dead or discharged men's effects, and "R.M.E." those for deserters; the totals of each class being shown separately on the folios, and also the summary of the ledger.

# REMITTANCES TO MEET PAYMENT OF SHIP'S OFFICIAL N.O. 15-ACCOUNTS.

Where it is necessary for special reasons for H.M.A. ships to make remittances to meet payment of ship's official accounts, bank drafts should be obtained from the Commonwealth Bank in all cases where a branch of the bank exists. #### LETTERS POSTED IN THE UNITED KINGDOM.

1. Arrangements have been made with the General Post Office, London, to collect all letters posted in the United Kingdom for H.M.A. ships, and to seal the letters for each ship in separate bags.

2. The General Post Office, London, will despatch the mail bags weekly with the Australian mail, addressed to c/o Postmaster, Fremantle, Western Australia (except those specially addressed as denoted in paragraph 3). The Postmaster, Fremantle, will be informed by the Navy Office, Melbourne, of the ports to which the bags are to be forwarded, and will arrange for the immediate re-shipment of the mails as required.

3. Mails for the following ships will be forwarded direct from London to the ports named:—H.M.A.S. Penguin, Sydney; H.M.A.S. Tingira, Sydney; H.M.A.S. Cerberus, Williamstown, viâ Melbourne; and H.M.A.S. Gayundah, Brisbane.

4. A letter bill and list of registered letters will be enclosed in each mail bag. Registered letters are to be recorded in a book kept by the Commanding Officer for the purpose, and the receipt of the addressee obtained therein.

5. Letters upon which any charge is to be levied by the Postal Department will be fastened together, with a statement attached giving the number of insufficiently prepaid letters, and the total amount of the charges thereon, and will be enclosed in a bag for each ship. All such charges are to be collected by the Accountant Officer of the ship, who is to remit quarterly the total sum so collected to the Deputy Postmaster-General, General Post Office, Melbourne, accompanied by the statements referred to.

6. The English mail is received in Melbourne, at the Spencer-street Railway Station, each Sunday, and mails for any of H.M.A. ships lying in Hobson's Bay may be obtained from the Postal official at the train, upon production of an order duly signed by the Commanding Officer of the ship. #### MOTOR BOATS-PREVENTION OF FIRE.

N.O. 19

Lamps.—No lamps other than electric lamps are to be used in the engine-room. All boats which are not already fitted with electric light, and which may be required for night duties, and all new boats, are each to be provided with one portable accumulator lantern for lighting the engine-room, and one spare accumulator for same.

Fuel Tank.—The fuel tank is to be filled during daylight N.O. 19 hours only. When filling from petrol or kerosene tins, a 1915, McKnight filler is to be utilized, in order to avoid spilling. continued.

A copper piercer of suitable dimensions for the McKnight filler is to be used for opening the tins.

Bilges.—The bilges are to be kept dry, to prevent the possibility of any petrol spilled in the engine-room being carried into any other compartment.

Flooring Boards. - Flooring boards in the engine-room are to be made portable, and of sufficiently small dimensions to enable them to be quickly removed. They are to be painted all over.

Fire Extinguisher .- An "Electrone" No. 1 fire extinguisher, and a supply of sand, are to be kept in the engineroom in readily accessible positions.

The following items are also to be stocked at each boat's head-quarters for use when refilling fire extinguishers:-

3 No. Valves.

1 No.

Pump, 125 lbs, pressure. Quart tins of "Electrene" (spare). 2 No.

Remarks.-It has been found by experiment that petrol burning in bulk cannot be extinguished. However, if the spirit is spilled over wood and set on fire, it is easily extinguished by the aid of an extinguisher or sand, or both, if applied before a large quantity of oil is allowed to accumulate.

Demands .- H.M.A. ships and Establishments should demand from the Naval Store Officer, Williamstown, any of the articles mentioned above that may be required. (N. 14/8996.)



#### QUARANTINE REGULATIONS ON ARRIVING AT AUSTRALIAN PORTS.

N.O. 23

1915.

The attention of Commanding Officers and Medical Officers is called to the necessity for strict compliance with the Commonwealth Quarantine Regulations.

- 2. On first entering a port of the Commonwealth from oversea, that is to say, from any place other than New Zealand and Fiji, it is incumbent upon the ship to obtain pratique before proceeding into harbor and anchoring.
- 3. The Quarantine Officer will board the ship, make the necessary inquiries from the Medical Officer, and grant pratique if the written report signed by the Commanding Officer and the Medical Officer is considered satisfactory. In the case of ships in company, the Senior Officer's ship only will be boarded.
- 4. This regulation applies only to vessels carrying a Medical Officer. In other cases an inspection by the Health Officer will be necessary. (N. 15/1053.)

#### ENTRY OF ENGINEER OFFICERS.

- For the information of Commanding Officers, the con-1915. ditions governing the entry of engineering graduates to the Royal Australian Navy are as under:-
  - 1. All candidates nominated by the Universities are required to have completed a University Course of not less than four years in Mechanical Engineering. Exceptional cases of graduates in other branches of Engineering will be considered on their merits.
  - 2. Not to have less than twelve months' workshop experience in the aggregate.

3. To be medically fit, according to the requirements pre- N.O. 28 scribed for service in the Royal Australian Navy.

4. Age not to exceed 24 years, except in special circum- continued. stances.

5. Candidates on entry to be given the rank of Probationary Engineer Sub-Lieutenant, with the pay and allowances as laid down for Engineer Sub-Lieutenants on promotion. Probationary Engineer Sub-Lieutenants only to provide themselves with the minimum requirements of Naval Uniform, and to be granted their Uniform Allowance for a year in advance on entry (£18 5s.).

6. Probationary Engineer Sub-Lieutenants to be confirmed in the rank of Engineer Sub-Lieutenant after a year's training in ships or Naval Establishments on passing the prescribed examinations in the courses of instruction which they have undergone.

7. Seniority in rank to date from original entry as Probationary Engineer Sub-Lieutenant, and service as such to count as full time.

8. Engineer Sub-Lieutenants to be eligible for promotion to Engineer Lieutenant on completion of two years' service in the confirmed rank of Engineer Sub-Lieutenant, provided they have passed the prescribed examination, and are recommended for promotion. This period may be reduced in the case of officers displaying conspicuous ability.

#### Examination for Engineer Lieutenant.

- 9. (1) The Examining Board is to consist of an Engineer Officer not below the rank of Engineer Commander and an Engineer Commander or Engineer Lieutenant Commander. The examination is to be conducted in the presence of a Captain or Commander, or of such officer as may be nominated for the purpose.
  - (2) Qualifications-
    - (i) All the qualifications required of an Engineer Sub-Lieutenant.
    - (ii) Be fully competent to perform the various duties of an Engineer Lieutenant.
    - (iii) Be well acquainted with the principles upon which marine engines work in all their parts.
    - (iv) Able to adjust the various working parts, and set right defects which may arise in the engineroom department.
    - (v) Be in every respect competent to take charge of the engines in the absence of the Engineer
- (3) The result of the examination is to be noted on Form S. 435 as "Ordinary," "Creditable," or "Very Creditable." (N. 15/1038.)

#### N.O. 30 ADVANCEMENT OF WARRANT OFFICERS TO RANK OF MATE OR MATE (E). 1915.

The following regulations regarding advancement of Warrant Officers to rank of Mate or Mate (E) are published for information of Officers concerned:-

(1) A limited number of Warrant Officers who have served at least three years in that rank, two years of which must have been in a ship of war at sea, will be selected for advancement to the rank of Mate or Mate (E).

(2) At present, owing to the very few Warrant Officers serving in Royal Australian Navv. one Executive Warrant Officer, and one Artificer Engineer will be selected in alternate years, but in future, when the field of selection has become greater, the number of these promotions will be increased.

(3) Mates thus promoted will be appointed to seagoing ships for two years to gain experience in watch-keeping duties, navigation, gunnery, torpedo and signals. During this time, if they wish to qualify for further advancement, they will be required to pass examinations similar to those prescribed for Lieutenants wishing to be considered for appointment to Destroyers, King's Regulations, Appendix X, Part IV.

After two years' service as Mate, and subject to passing the above examinations, and provided they are well reported on and recommended for advancement, these officers will be promoted to Lieutenant, Royal Australian Navy.

(4) Mates (E) on being specially advanced as in N.O. 30 paragraph (1) will be appointed to sea-going ships for two years, during which time they will be required to pass the examination laid down for Engineer Lieutenant (Junior List), Appendix X., Part V., King's Regulations.

After two years' service as Mate (E), and subject to passing the above examination, and provided they are well reported on and recommended for advancement, these officers will be promoted to Engineer Lieutenant, Royal Australian Navy.

(5) Mates and Mates (E) will mess in the Ward Room, and rank with, but after, Sub-Lieu-

(6) Pay.-Mates and Mates (E)-active, 11s. per day; deferred, 2s. 9d. per day. Lieutenants and Engineer Lieutenants-as laid down in Financial and Allowance Regulations.

No married allowance will be paid to any of above. Mates and Engineer Mates, Lieutenants, and Engineer Lieutenants promoted from Warrant Officer, will be allowed 2s. per day messing allowance.

(7) This scheme admits of selections being made from the ranks of Stoker Warrant Officers, as well as those from Artificer-Engineers, for the rank of Engineer Mate.

(8) These regulations are framed after reviewing the present facilities in Australia for training Officers. As soon as circumstances render it possible, these regulations may be amended to include theoretical courses for both branches of Mates at Navigational and Engineering Colleges established on shore, and it is possible that, later on, the field may be widened by the selection of more junior ratings than Warrant Officers for the rank of Mate. #### N.O. 33 PASSAGES OF WIVES AND FAMILIES OF OFFICERS LENT FROM THE ROYAL NAVY. 1915.

1. Officers volunteering for service in the Royal Australian Navy for three years will be granted passage of wife and family to Australia. After completion of three years' service with Royal Australian Navy, a return passage will be granted for wife and family.

2. If, through reasons beyond an Officer's control, his service with Royal Australian Navy is terminated before expiration of the three years, the Commonwealth do not hold themselves responsible for the return passage of wife and family, but, on application being made, the whole or a portion of the return passage may be granted, after taking into consideration the circumstances attending the withdrawal of the Officer from the Royal Australian Navy.

3. Should private reasons necessitate the return of an Officer's wife or family prior to the completion of the three years' service, the money for this passage will not, as a general rule, be paid until this period has been completed; a portion, however, may be advanced on application being made, the amount being dependent on length of service of Officer in the Commonwealth Service.

4. Should an Officer's services with the Commonwealth be terminated owing to his misconduct or unsatisfactory service. or should an Officer voluntarily withdraw from the Royal Australian Navy prior to the completion of the period for which lent, the Commonwealth do not hold themselves liable for a return passage of the Officer's wife and family. (N. 15/2943.)

The real test of fitness is the candidate's likelihood to continue efficient and serviceable in any climate, and under all the vicissitudes of the service for a period of not less than 12 years. The examining officers must necessarily be guided by their own judgment as to whether defects in a minor degree are of sufficient importance to disqualify.

Special Entries.—Specially desirable (from the physical point of view) men and boys, although slightly under the physical standard, may be entered if the deficiency in height or chest measurement is more than counterbalanced by special general fitness, and if they are robust, intelligent, and of perfectly sound and healthy constitutions.

In every case in which a Medical Officer, in accordance with the discretionary power conferred upon him, passes a man or boy not entirely free from defect, he is to insert the particulars of such defects on the disability clause at bottom of A.R. 5. [The italicised words are in substitution for the words "Form S 271."]

#### QUALIFYING SERVICE BEFORE EXAMINATION FOR RATING OF LEADING SEAMAN.

N.O. 52

1915.

1. It has been decided to modify the Regulations regarding period of qualifying service required before examination for rating of Leading Seaman as laid down in Appendix XV. of King's Regulations, in order to allow an Able Seaman to pass for Leading Seaman after one year's service as Able Seaman, but not to be rated until he has served two years in the latter rating. It is to be understood, however, that there is to be no lowering of the present standard.

2. Until further orders, Able Seamen serving in sea-going ships who have passed and are thoroughly recommended may be advanced to Acting Leading Seamen to fill vacancies in complement, notwithstanding they have not completed 2

years' service. (N. 15/4596).

#### RATION ALLOWANCE.

On account of the additional cost of messing due to the 1915. abnormal conditions which have existed for some time past, the following has been approved and the necessary action is to be taken accordingly:-

(i) Any balance debit on the General Mess Account at 31st May, 1915, as shown on Form A.S. 73, is not to be carried forward into the Accounts for June.

(ii) From 1st June, 1915, the Ration Allowance for Seagoing Ships will be increased from 1s. 4d. to

1s. 8d. per head per diem.

#### SENATOR PEARCE'S VALEDICTORY.

Department of Defence, Melbourne, 13th July, 1915.

In severing my official connexion as Minister with the Naval Board and the Naval Department, in consequence of the creation of a separate Department for the Navy, I wish to express my appreciation to the Board and the officers of the Department generally of the magnificent work that has been done, firstly, in the creation of the Royal Australian Navy; and, secondly, in the discharge of the duties thrown upon the Department as a result of the war.

In 1908, before the establishment of the Naval Board, I had the honour of being the Minister to give the order for the torpedo-boat destroyers Yarra, Parramatta, and Warrego, the first vessels of the Australian Navv. From that modest commencement the Navy has grown, until to-day it has assumed such proportions as to be able to render invaluable aid to the Mother Country in the prosecution of the war, both on sea and land. The operation of the Fleet at sea constitutes a record, which will become a tradition associated with the Naval Department, of which future generations will speak with pride. The Naval Forces on land at New Guinea and in various duties for the Commonwealth have also rendered valuable service.

I cannot speak too highly of the tremendous work that has been successfully accomplished in connexion with transport services, and the utilization of captured German vessels for the cargo trade of Australia. The provision of officers and crews for these vessels alone was a work of great magnitude, and has been successfully carried through.

The transport arrangements by which 75,000 troops have been successfully conveyed over thousands of miles of sea, without the loss of a single ship and with regularity and precision, speak volumes for the work that has been done by the Transport Board.

In severing my connexion, I do so with some regret, as it has been a source of pride and satisfaction to myself to be associated with a service that has accomplished so much. I feel, however, that the incoming Minister will receive the same loyal support and hearty co-operation, from the highest officer in the Department to the youngest boy on the Tingira. which I have received in the past.

May the Royal Australian Navy go forward to still greater successes.

## PROMOTION WHILST SERVING IN THE ROYAL AUSTRALIAN NAVY ON LOAN FROM THE ROYAL NAVY.

Where an Officer, Petty Officer, or Man serving in the Royal Australian Navy on loan from the Royal Navy is promoted by the Admiralty, and is appointed forthwith to a ship of the Royal Navy, promotion in the Royal Australian Navy will not be made. Pay and allowances, in such cases, will be continued at the Royal Australian Navy rates for the rank or rating held prior to Admiralty promotion until final discharge from the Royal Australian Navy. Pay and allowances of the higher rank or rating at Admiralty rates will commence from the day following discharge from the Royal Australian Navy, and not from date of promotion, and no allowance will be made on account of any difference between Royal Australian Navy rates for the lower rank or rating and the Admiralty rate for the higher rank or rating for the period between the date of promotion and date of discharge from the Royal Australian Navy.

2. In cases where Admiralty promotion does not involve N.O. 71 immediate return to the Royal Navy, but an Officer remains in the Royal Australian Navy with the intention of completing his engagement with the Commonwealth, he will be promoted in the Royal Australian Navy with his proper seniority, and will receive pay and allowances in the higher rank as from the date he is re-appointed to one of H.M.A. Ships in his new rank. # SPECIAL ALLOWANCE ON ACCOUNT OF A DEPENDENT N.O. 90 MOTHER. 1915.

Payment of an allowance of 1s. per diem to Chief Petty Officers, Petty Officers, and other ratings of the Royal Australian Navy, who are in receipt of sea-going rates of pay, has been approved as from 1st June, 1915, and during the currency of the war, under the following conditions:—

(a) Mother to be solely dependent on her son's earnings for support.

(b) Mother to be resident in Australia.

(r) Allowance not to be paid to a rating unless he declares a monthly allotment in favour of his mother of at least £2 10s. per month.

(d) Allowance not to be drawn when lodging allowance is paid.

(e) Allowance not to be paid when married allowance is drawn.

#### AUTHORITY FOR PAYMENT.

I. Ratings eligible to receive the allowance under the conditions laid down in this Navy Order should make application through their Commanding Officer to the Naval Secretary on Form 1299y in duplicate.

II. The mother of an applicant for this allowance will be required to sign a statutory declaration before a justice of the peace or commissioner for declarations that she is solely dependent on her son for support, &c.

III. Commanding Officers before forwarding the application should satisfy themselves, as far as practicable, that the statements contained on the above form are correct.

IV. The necessary authority for payment will be issued by the Naval Secretary, and, on receipt, payment is to be made accordingly. After notation by the Accountant Officer, the authority is to be attached to the rating's Certificate of Service.

V. The Naval Board may stop or withhold payment of this allowance when considered desirable, at any time.

#### ADJUSTMENT OF ACCOUNTS OF DESERTERS.

The ledger accounts of deserters from the Royal Australian Navy are to be adjusted to include credits of pay, both active and deferred, and clothing gratuity for the actual date of desertion, notwithstanding that desertion may have occurred in the fore or afternoon of that day.

The method of adjusting the victualling is to be continued as heretofore, fixed by the time of desertion, i.e., before or after noon, vide King's Regulations and Admiralty Instructions, Art. 1684.

The date of desertion as shown on the quarterly ledger must, in all cases, coincide with that inserted on page 2 of the Certificate of Service.
